Function and Purpose

The Banner by Ellucian System **Super User Group** and **Steering Committee** are responsible for guiding the ongoing implementation and use of Ellucian's Banner products at New River CTC. Through ongoing communication and close collaboration, these two groups will guide both our day-to-day use of these products as well as developing plans for our longer-term use (e.g., reviewing and implementing aspects of the three-year Ellucian Action Plan). When an institutional issue arises regarding the Banner by Ellucian system, meetings will be scheduled as needed. These two groups have oversight responsibility for training and development of staff members who use the Banner by Ellucian products, to include those who use only the Self-Service interface (employees and students). Communication among these groups is facilitated by the NRCTC-BANNERUSERS-L listserv that is comprised of all members of these two groups as well as additional New River Banner by Ellucian users (currently about 70 total subscribers). The **Vice President for Technology and Library Services** chairs the **Steering Committee**. The **Database Administrator Senior** chairs the **Super User Group**. The Super User Group reports progress to the Steering Committee and the Steering Committee reports findings and recommendations to the President's Cabinet.
